WE HEREBY WAIVE, RELEASE, HOLD HARMLESS AND FOREVER DISCHARGE THE V & P SHARKS 6-MAN FOOTBALL PROGRAM AND VICTORY & PRAISE WORSHIP CENTER, IT'S DIRECTORS, PASTORS, OFFICERS, COACHES, TRAINERS, MANAGERS, OFFICIALS, AGENTS, EMPLOYEES, SPONSORS, REPRESENTATIVES, SUCCESSORS AND ASSIGNS (THE "RELEASED PARTIES") AND FROM ANY ALL CLAIMS FOR DAMAGES THAT MAY ARISE FROM THE PARTICIPANT'S PARTICIPATION IN PRACTICES FOR AND PARTICIPATION IN THE SEASON (INCLUDING TRAVEL TO AND FROM PRACTICES AND THE GAME ITSELF); AND
- B. WE HERBY WAIVE, HOLD HARMLESS AND FOREVER DISCHARGE THE RELEASED PARTIES OF AND FROM ANY AND ALL CLAIMS FOR DAMAGES, INJURY OR LOSS TO PERSON OR PROPERTY WHICH MAY BE SUSTAINED DURING PARTICIPATION IN EVENTS TO, OR PRACTICES IN PREPARTATION FOR, OR PLAY IN ANY GAME, WHETHER OR NOT DAMAGES, INJURY OR LOSS IS DUE IN WHOLE OR PART TO THE NEGLIGENCE OF ANY OF THE RELEASED PARTIES.
